# Does the city have leash law?

Yes, dogs must be on leashes, and the leash must be held by the person at all times so as to not create a nuisance.

# 705.02 Dog License/Dogs Under Control or Running at Large

- (a) Every person who owns, keeps or harbors a dog more than three months of age in the city of Shaker Heights shall obtain and maintain a current dog license issues by the Cuyahoga County Auditor. Please see attached application for dog licenses.
- (b) Any person, being the owner, keeper or harborer of any dog, when the dog is on the premises of its owner, keeper or harborer, shall keep the dog physically confined or restrained upon the premises by a leash, supervision and/or secure enclosure to prevent escape.
- (c) The entry of any dog upon any public or private property within city limits of this City, other than the property of the owner, keeper or harborer of such dog, shall constitute running at large, unless such dog is securely leashed or under such control of the owner, keeper or harborer so as to prevent the dog from being or creating a nuisance. No person, being the owner, keeper or harborer of any dog shall permit the dog to run at large within city limits.

### 705.03 Nuisance Conditions Prohibited

## What is a criminal activity nuisance?

Violations of certain City laws at a residential property may be declared nuisances if they are engaged in by (a) the owner, (b) any occupant, (c) any guest of the owner or any occupant. Any animal is hereby declared to be committing a nuisance if it:

- (1) bites another person or domestic animal;
- (2) barks, howls or yelps in a menacing fashion, frequently and habitually in such a manner that the barking, howling or yelping is unreasonably loud or disturbing and of such character, intensity and duration as to disturb the peace and quiet of the neighborhood.

- (c) Any animal which scratches, digs, urinates or defecates upon any lawn, tree, shrub, plant, building or any other public or private property, other than the property of the owner, keeper or harborer of such animal, is hereby declared to be a nuisance.
- (d) No person being the owner, keeper or harborer of any animal shall allow or permit such animal to commit a nuisance on any private property other than that of the owner, keeper or harborer of such animal, without the permission of the owner of such property. There the owner, keeper or harborer of such animal immediately removes all feces deposited by such animal and disposes of same in a sanitary manner, such nuisance shall be considered abated.
